You can take the test as many times as needed but it will cost you \$62 each time and you must pass both parts within a 6-month period and make application for your license within the same 6-month period. You'll need two forms of signature bearing identification at the testing site, one picture bearing government issued. If you pass one part of the test you won't be required to take it over providing you pass the other part, complete the Practice course and make application within the 6month period. The certificate you get from us is also good for 6 months. Prior to making application for your license you'll have to complete a 24-hour course titled Missouri Real Estate Practice Course. Our practice course is \$155. It does not require a state test. After passing the state test you'll need a sponsoring broker. Your license fee depends on your state of residence. MO resident's current fee is \$90. Out of state fee is \$150. You'll need to talk to your broker to see if they have any other fees you will have to pay. If they are members of the Board of Realtors and MLS you will be required to join. This can easily be several hundred dollars. Some brokers have a desk fee. Your salesperson license will be good until September 30th of the next even numbered year. During this period of time you will be required to complete 12 hours of continuing education.
